RULES FOR MEMBERSHIP

1. The Association is a non profit making, charitable organization that aims to bring Old Wilsonians together to build camaraderie among old students and also be a link of alumni with the School/ College.

2. Any person eighteen years of age or over who is an alumnus of Wilsonia Group of Educational Institutions and who is of good moral character, and who is in agreement with the aims and objectives of the Association, irrespective of religion, caste, class, creed, color, sex, or race shall be eligible for membership.

3. Membership may be of Two types a. Life Membership b. General Membership

4. Life Members - Any member paying Rupees Five Thousand at the time of joining shall be entitled to be a Life Member.

5. General Member - Any member paying the Annual membership fee of Rupees Five Hundred per year shall be an General member.

6. Life Members are entitled to hold office on the Board of Directors.

7. All members have the right to vote, but General members cannot hold office on the Board of Directors.

8. The Secretary shall receive Applications for membership in the prescribed form and shall submit them to the Board for consideration.

9. Awarding membership shall be subject to scrutiny of the candidate's reputation and past record.

10. The Board of Directors has the discretion to refuse membership if it feels that it is in the best interest of the Association.

11. Annual Membership fee of Rupees Five Hundred per year shall be payable by all General members in the month of April.

12. All fees shall be subject to increase from time to time as determined by the Board of Directors.

13. Membership is not transferable and Membership fee is not refundable.

14. Members shall be informed time to time about the events, activities and meetings of the Association.

15. Membership fee can be paid by Cash or Demand Draft in Favour of 'Old Wilsonians' Association' payable at Moradabad.
